CREDENTIALING TIPS – Considerations for DTR or NDTR Exam Eligible Individuals

Individuals who have been approved by the Commission on Dietetic Registration (CDR) for registration examination eligibility, need to consider the below when moving forward with eligibility status.

Exam Candidate Status Before Passing the Exam

The Dietetic Technician, Registered (DTR®) or Nutrition and Dietetics Technician, Registered (NDTR®) credential is awarded by the CDR to individuals who meet <u>specific academic and supervised practice</u> <u>requirements</u> and successfully pass the registration examination for dietetic technicians. NOTE: Eligible Individuals cannot preliminarily use the DTR or NDTR credential since eligibility to take the entry-level exam is not an indication that an individual will schedule, take or pass the exam.

What does the term registration eligible mean?

The term *registration eligible* is used by CDR to identify individuals who have met didactic and supervised practice requirements and have established eligibility to take the registration examination. Verification of exam eligibility status can be provided by emailing cdrexams@eatright.org.

DTRE and NDTRE Misuse

Candidates approved for exam eligibility have agreed to the CDR DTRE or NDTRE Misuse Policy.

The agreement covers the following:

- DTRE is an acronym for Dietetic Technician (DTR) Eligible and NDTRE is an acronym for Nutrition and Dietetics Technician (NDTRE) Eligible and must not be utilized.
- "dtr" or "ndtr" must not be used in an email address, website domain, or social media handle **prior to** passing the exam. Examples **not** to use until an individual passes exam are:
 - o JaneDoe@AspiringDTR.com
 - o JoeSmith@FutureChefNDTR.com
 - o JaneDoePursingNDTR@gmail.com
 - Jane Doe, DTRE
 - Joe Smith, Dietetic Technician Eligible

Nutrition and Dietetics Practice and the Registration Eligible Individual

How a organization handles the registration eligible individual in an employment role is a facility based decision. Protocols for patient/client/resident nutrition care service functions and electronic health record charting must adhere to Federal regulations in Conditions of Participation, Conditions for Coverage, and Minimum Data Sets. The definitions for qualified dietitian, Registered Dietitian, and clinically qualified nutrition professional list responsibilities and qualifications for Hospitals, Critical Access Hospitals (CAHs), End Stage Renal Facilities, and Skilled Nursing Facilities (SNFs).
